Registration forms can be obtained at [mi.gov/vote](https://mi.gov/vote) and mailed to the Township Clerk. Voters who are already registered may update their registration at <https://mvic.sos.state.mi.us/RegisterVoter>.

The last day to register in any manner other than in-person with the local clerk is **Monday, October 21, 2024**.

After this date, anyone who qualifies as an elector may register to vote in person with proof of residency (MCL 168.492) at the Southfield Township Clerk's office, located at 18550 W. 13 Mile Rd, Beverly Hills, MI 48025 at the following times:

- Regular business hours: Monday through Friday from 8:30 a.m. to 5:00 p.m.
- Saturday, November 2, from 8:00 a.m. to 4:00 p.m.
- Election Day: Tuesday, November 5 from 7:00 a.m. to 8:00 p.m.
