MINUTES OF THE SOUTHFIELD TOWNSHIP BOARD OF TRUSTEES MEETING HELD ON AUGUST 11, 2015

Supervisor Schmitt called the meeting to order at 7:30 p.m. at the Township Hall.

Supervisor's Report

Supervisor Schmitt thanked Clerk Tischler, Treasurer Mooney and Trustee Nelson for doing maintenance to the landscaping of the Township Hall.

Supervisor Schmitt commented a resident who came in to pay her taxes, was most appreciative of the new doors.

Clerk's Report

Clerk Tischler stated with installation of the Handicap Entrance doors, a request for reimbursement has been submitted to the State in the amount of \$9,920.

Clerk Tischler commented 858 dog licenses have been issued as of July 31st compared to 838 at this time last year and 37 cat licenses have been issued compared to 47 last year.

Clerk Tischler noted the Planning Commission will meet on August 25th, at this time their agenda will only contain appointment of officers and meeting dates.

Clerk Tischler stated the Township Office will be closed on September 7th for the Labor Day Holiday.

Clerk Tischler noted the Municipal Employees' Retirement System second quarterly statement was provided with this evening's information items.

Treasurer's Report

Treasurer Mooney commented to date, we have collected 18% of the summer tax collection with a little over a month to go.

PUBLIC COMMENTS ON ITEMS NOT CONTAINED ON PUBLISHED AGENDA:

No one wished to be heard.

APPROVAL OF AGENDA:

Supervisor Schmitt requested two items be added to the agenda, 14a Approval and Possible acceptance of resignation of Trustee Koss and 14b Announcement of vacancy on the Board of Trustees.

Motion by Mooney, supported by Walsh, the agenda be approved as amended.

Motion carried unanimously.

<u>DISCUSSION AND POSSIBLE APPROVAL OF JUNE 9, 2015 REGULAR MEETING</u> MINUTES:

Trustee Cook suggested on page 4 under (B) (1), fifth sentence down, "finales" should be "finials" after "decorations" and after "decorative".

Trustee Walsh noted on page 9 under "Comments from the Board" second paragraph, first line after "Township" insert "website" and second line after "Nelson" insert Supervisor Schmitt and Trustees Cook and Walsh".

Motion by Walsh, supported by Cook, to approve the June 9, 2015 Board meeting minutes as amended.

Motion carried unanimously.

PUBLIC HEARING FOR POLICE AND FIRE SPECIAL ASSESSMENT DISTRICTS:

Supervisor Schmitt opened the Public Hearing for comments on the Police and Fire Special Assessment Districts for Township Only Residents from the Village of Beverly Hills, Bingham/Franklin Farms Volunteer Fire Department and Police Services from the Village of Franklin for 2015-2016 at 7:38 p.m.

No one wished to be heard.

Supervisor Schmitt closed the public hearing at 7:39 p.m.

PRESENTATION OF TOWNSHIP AUDIT, RECEIVE AND FILE:

Supervisor Schmitt introduced Rana Emmons, Auditor from Post, Smythe, Lutz and Ziel (PSLZ LLP). Emmons presented the Southfield Township Audit for fiscal year ending March 31, 2015. Emmons discussed the following areas: Property tax collection noting a slight increase in taxable value of 2.2%. Emmons stated the fund balance of the Township's general fund decreased by \$41,280 during the current fiscal year. Emmons noted that next year there will be changes in GASBY 68 Pension/Liability, which will have minimal impact to Southfield Township. Emmons stated that next year's audit will account for Post-Retirement Health Care. Emmons commented again on the consistency of the millage rate and operating expenses.

Emmons answered all questions.

Trustee Cook expressed her appreciation for the presentation and specifically pages 3-6 of the Audit.

Emmons suggested attention to page 24 of the Audit, which presents the general fund budget to the actuals, as a good place to focus.

Emmons stated there are no specific recommendations for the Township and noted the audit for the fiscal year ending March 31, 2015 was favorable, clean and in good standing.

Emmons noted all the necessary forms have been filed with the State prior to the deadline of September 30th.

Supervisor Schmitt thanked Emmons for the presentation.

Motion by Tischler, supported by Walsh, to receive and file the March 31, 2015 Township Audit.

Motion carried unanimously.

<u>DISCUSSION AND POSSIBLE APPROVAL OF RESOLUTION TO ASSESS 3% TAX</u> PENALTY FOR THE 2015 TAX YEAR:

Resolved by Mooney, seconded by Schmitt, that the following Resolution be adopted:

WHEREAS, with the passage of Public Act #206 of 1893, as amended, MCL 211.44, as amended, which authorizes the Township of Southfield Board of Trustees to impose a penalty on all late payments of unpaid property taxes; and

WHEREAS, the last date to pay taxes by law is February 16, 2016; and

WHEREAS, all taxes paid after February 16, 2016 and before March 1, 2016 are termed late:

NOW, THEREFORE, BE IT RESOLVED that the Southfield Township Board of Trustees authorizes the Township Treasurer to levy a 3% penalty on all late taxes paid after February 16, 2016 through February 29, 2016; and

BE IT FURTHER RESOLVED that a copy of this Resolution be published in The Birmingham/Bloomfield Eccentric and a notice be included in the mailing of all tax statements to alert all taxpayers of this enactment.

DISCUSSION OF FEE SCHEDULE FOR FREEDOM OF INFORMATION ACT:

Clerk Tischler mentioned the Board has been provided with the current fee schedule. The Township's current copying policy was adopted in December of 2005; has been not to charge for any copies requested either by residents or non-residents.

Clerk Tischler commented most often the copies requested are duplicates of tax bills, assessment records and property transfer or rescind forms. Currently, Board packets are handled by e-mailing the information.

Clerk Tischler noted our current Fee Schedule which lists specific items other than copies of paper items along with documentation from McKenna Associates related to planning services.

Clerk Tischler commented most often the Township FOIA requests have been for dog bites. Clerk Tischler noted it might be appropriate for the Township Board to review the Fee Schedule and identify specific records or types of records it deems should be made available at no charge or at a reduced cost in order to complete the required FOIA forms. Clerk Tischler asked the Board for direction.

Clerk Tischler noted the only item that has not required the filing of a FOIA request is Election information. A flat fee for election items has been used i.e. disc, labels, paper or e-mail. Clerk Tischler noted that research will be done by contacting other jurisdictions in order to compare how Election information requests are now being handled.

Clerk Tischler requested direction from the Board, whether or not to charge and how much to charge for FOIA request, or if a maximum number of copies for free copies should be set, by contacting Treasurer Mooney or myself.

Trustee Cook agreed with polling other jurisdictions to see what they charge for Election material and charging a fee after supplying a certain number of pages for a FOIA request.

Treasurer Mooney responded the Township does not have that many FOIA requests or copy requests.

Clerk Tischler stated the office staff will work together and present a solution at the next meeting.

REVIEW AND CONSIDER REQUEST TO WAIVE THE PROPERTY TRANSFER AFFIDAVIT FEES FOR PARCELS IN FRANKLIN:

Treasurer Mooney reviewed a letter from the attorney of parcel owner, Michael Slesinski requesting a waiver of the Property Transfer Affidavit fees totaling \$2,400.00. Also attached are copies of the Deeds for the four parcels in question. Two parcels are contiguous residential lots. The other two parcels are contiguous commercial lots.

Treasurer Mooney stated there was a legislative change in 2013 that took effect in 2014 that had unintended consequences which were corrected for 2015. This transfer occurred in 2014 before the correction was made. Treasurer Mooney noted Property Transfer Affidavits were required either way but the fines would not have been imposed in 2013 or 2015, only in 2014.

The Board has the ability to waive some or all of the fees or to deny the request in its entirety.

Treasurer Mooney asked the Board if they had any questions.

Treasurer Mooney and Supervisor Schmitt answered all questions.

Trustee Cook reviewed the information provided by the Township attorney and noted waiving all or part of the fees is completely within the discretion of the board.

Supervisor Schmitt asked the Board if they would like to take any action.

After general discussion, the Board made the following motion.

Resolved by Walsh, supported by Cook, to waive the 2014 Property Transfer Affidavit fees for all four parcels; TF-24-06-201-005; TF-24-06-201-006; TF-24-06-205-003 and TF-24-06-205-013 in the amount of \$2,400.00.
